The Foreign Account Tax Compliance Act (FATCA) was signed into U.S. law on March 18, 2010. It is aimed at preventing U.S. taxpayers from using accounts held outside of the U.S. to evade taxes. Any financial institution that fails to comply with FATCA will face a 30% withholding tax on a wide range of U.S. sourced payments to its clients. Under U.S. federal tax law, Lakson Investments Limited is required to request certain taxpayer information from certain persons who maintain an account at Lakson Investments Limited (whether such persons are U.S. taxpayers or not).
